Further to your recent enquiry, we are pleased to submit our quotation as follows

To manufacture and install into your timber frame 1 set of glass double doors. Doors to open in have brushed stainless steel mounted patch lock with keeper plate, brushed stainless steel hydraulic no hold open closers, 305mm long dark bronze pull handles. Toughened 10mm clear glass with frosted signage as per architect's image.

All for the sum = Total £2,841.00+ VAT

The above price is for the glass doors only. These are to be installed into the timber frame made by others.

Signage to be approved by customer once designed.

Price increases

The entire construction industry is experiencing significant increase. CS expects this situation to continue for a period of time until supply capacity realigns with demand.

Once the deposit has been paid the contract with CS Glaziers will begin. If there is any price increase from when the deposit is made to when the products are ordered CS has the right to pass on any increases to the customer.

Quotation

If CS is installing the quotation cost is subject to site survey.

The quotation is valid for 1 month from the quote issue date.

Lead times for supply & install are 5 to 8 weeks from date of final measure.

Lead time for supply only is 4 to 7 weeks from deposit/final sizes.

Any lead times given are only approximate. Lead times may vary depending on schedule of work and suppliers.

When looking at paper brochures and PDF brochures variations in colour may be different to the real colour.

Colours should be checked using a Ral chart or wood/pattern chart.

Survey

Once the quotation has been agreed you will then have a site survey. A site survey is to assess the logistics, the opening the item is to be installed in to and to take measurements. CS will not remove existing items on the day of the site survey. When we remove the item on the day of installation and there are potential issues with your opening CS will not be held responsible for unforeseen issues.

Once a final survey has been undertaken the final drawings will be issued and any on-site agreement to be confirmed in writing.

Ordering

Products will only be ordered when a deposit has been made. Once the deposit has been made by Pro former Invoice or card payment the contract with CS Glaziers will begin. The contract will be regarding the details on your quote/invoice.

Access

All lifting and access equipment must be provided by the customer unless specified in the quotation. If specialist access or lifting is required a site meeting is to be arranged between your supplier and CS Glaziers prior to works commencing.

Goods inspection

Once the product is installed the protective tape will be removed. You must be present to check the frame and glass for any sign of damage. If the products have no sign of damage a goods inspection document will need to be signed.

If you cannot be present on the day of installation CS will require this frame to be checked within 24 hours.

If the product is supply only, you must check the product at the time of delivery or collection for any issues with the product.

Glass supplied will conform to the relevant visual quality standard of the glass and glazing federation.

Glass units that have been supplied by other companies due to being oversize will be to the best commercial standard.

Aluminium supplied will conform to the powder coaters specifications/standards.

Silicon will be tooled as per our sealant supplier's specification to a minimum size of 10mm, applied using a gauged tooling method. All external silicon seals are functional and not for appearance.

Markings

Toughened glass and Laminated glass used in critical locations in buildings must be permanently marked to show compliance with BS6262 part 4 1992. Therefore, all safety glass will carry a visible stamp.

Payment

We will accept Debit cards and online bank payment.

Credit cards if paying with a card registered to a business will have a 2% charge on payments over £500.

Terms and conditions

Supply & Install = 50% deposit required with order, 40% two weeks prior to installation and balance on completion.

Supply only = 50% deposit required with order and balance prior to collection.

Whilst every effort has been made to interpret your request accurately, it is your responsibility to ensure that the goods quoted for match your requirements. CS Glaziers cannot be held responsible for any errors or omissions.

CS will not be liable for any consequential loss however arising.
